

Amendment to Gambling Act (Casino Gambling Equipment) Minimum Standard 2004

Pursuant to section 327 of the Gambling Act 2003, I Catherine Jane Reid, acting under authority delegated to me by the Secretary for Internal Affairs, prescribe the following amendment to the Gambling Act (Casino Gambling Equipment) Minimum Standard 2004.

Casino Other Gambling Equipment

Rules of Casino Table Games

The Gambling Act (Casino Gambling Equipment) Minimum Standard 2004 is amended by incorporating all of Amendment No. 20 to the Rules of Casino Table Games as resolved by the Casino Control Authority on 18 June 2004 and published in the New Zealand Gazette, Issue No. 76 on 24 June 2004.

Rules of Casino Keno, Racing Game and Gaming Machines

The Gambling Act (Casino Gambling Equipment) Minimum Standard 2004 is also amended by incorporating part of Amendment No. 8 to the Rules of Casino Keno, Racing Game and Gaming Machines as resolved by the Casino Control Authority on 18 June 2004 and published in the New Zealand Gazette, Issue No. 79 on 29 June 2004.

The minimum standard for the design, manufacture, and performance of gambling equipment as contained in Amendment No. 8 to the Rules of Casino Keno, Racing Game and Gaming Machines to be incorporated is:

- “5. Division V – Australian/New Zealand Gaming Machine National Standard, Revision 5.0, 4 January 2002, and New Zealand Casinos’ Appendix to the Australian/New Zealand Gaming Machine National Standard Version 5.0, Appendix Version 1.0

Division V is amended by deleting the New Zealand Casinos’ Appendix to the Australian/New Zealand Gaming Machine National Standard Version 5.0, Appendix Version 2.0 (dated January 2002), which was inserted at the end of Division V after the New Zealand Casinos’ Appendix to the Australian/New Zealand Gaming Machine National Standard Version 5.0, Appendix Version 1.0, by rule 3 of and Appendix A to then Rules of Casino Keno, Racing Game and Gaming Machines Amendment No. 7.

6. Division VI – Australian/New Zealand Gaming Machine National Standard, Revision 6.0, 6 December 2002, and New Zealand Casinos’ Appendix to the Australian/New Zealand Gaming Machine National Standard Version 5.0, Appendix Version 2.0

Division VI is amended by inserting the New Zealand Casinos' Appendix to the Australian/New Zealand Gaming Machine National Standard Version 5.0, Appendix Version 2.0 (dated January 2002), being Appendix A to Schedule 3 of the Rules of Casino Keno, Racing Game and Gaming Machines Amendment No.7, at the end of the division after the Australian/New Zealand Gaming Machine National Standard, Revision 6.0 (dated 6 December 2002).”
