Timeframe

A Certificate of No Impediment to an intended civil union cannot be legally issued less than 14 days from the date of receipt of this notice, but if your certificate requires legalisation and/or endorsement, you should allow 6 weeks for processing.

Confirmation of your Eligibility to Enter into a Civil Union

Your parent/s, relative or friend will be sent a letter asking that they confirm that they know of no lawful impediment to you entering into a civil union. Please ensure the address you provide for them is accurate as your certificate will not be issued until Births, Deaths and Marriages has received their letter in response. Please indicate if either parent is deceased.

Recognition of Overseas Civil Union

Your civil union should be registered in the country where it takes place, and you will be able to obtain certificates relating to that civil union from that country. Civil unions in an overseas country are not able by law to be registered in New Zealand.

Some overseas relationships are recognised as civil unions in New Zealand. To find out if the overseas relationship you intend to enter into is recognised in New Zealand you may wish to contact us by visiting our website www.bdm.govt.nz or Freephone 0800 22 52 52 (within New Zealand only). We also recommend that you seek legal advice about the status in New Zealand of your overseas relationship, and about the consequences of entering into another relationship in New Zealand or elsewhere at a later date.
